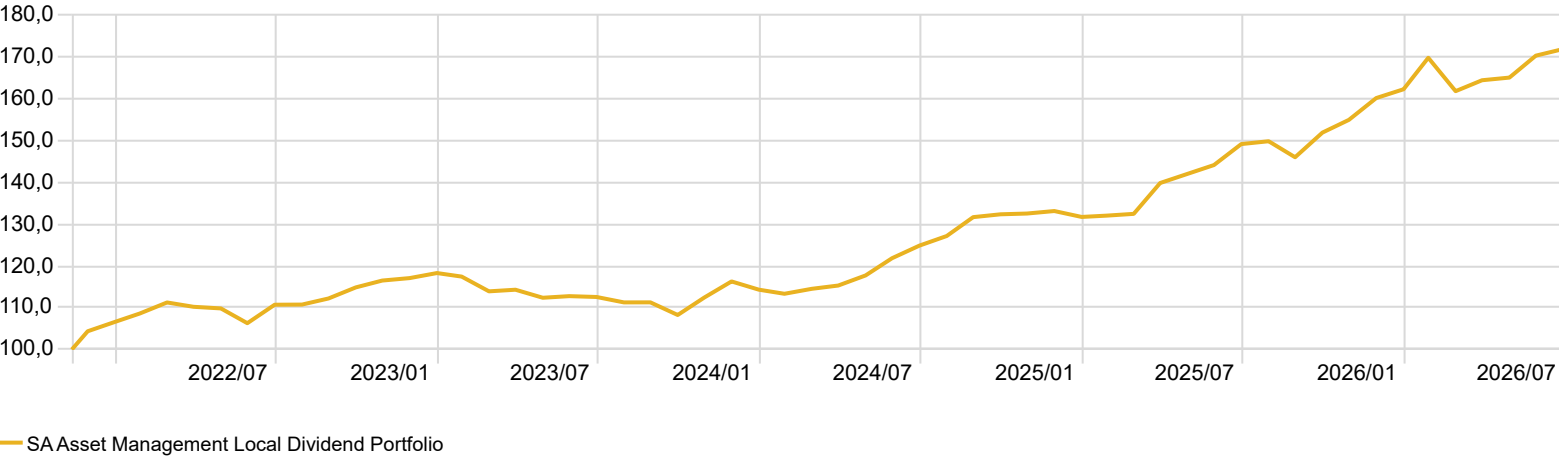

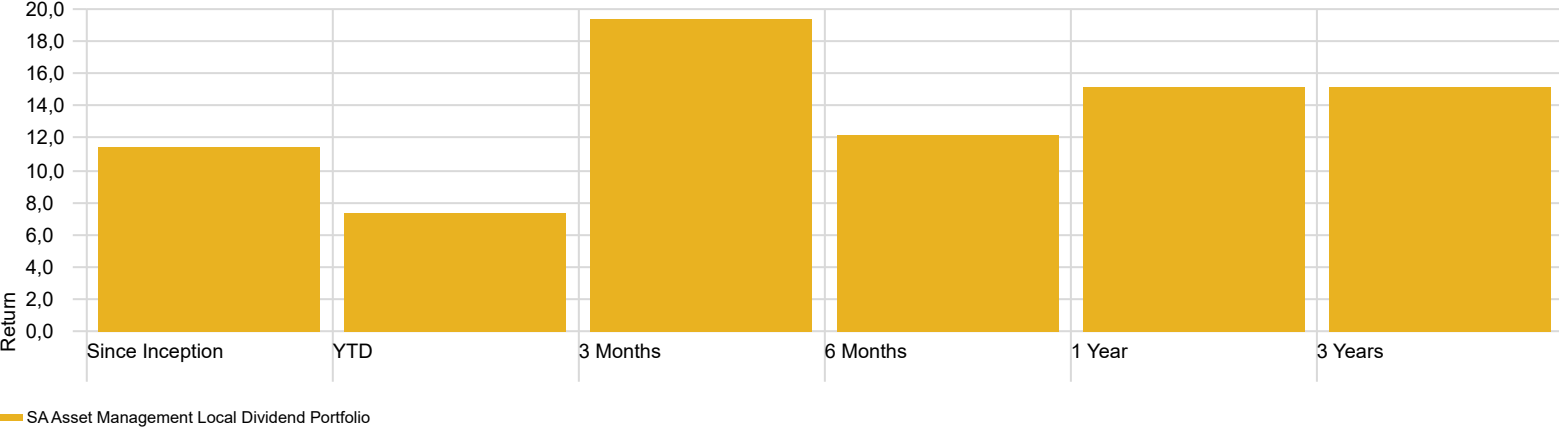
Investment Growth - 5 Year (ZAR)

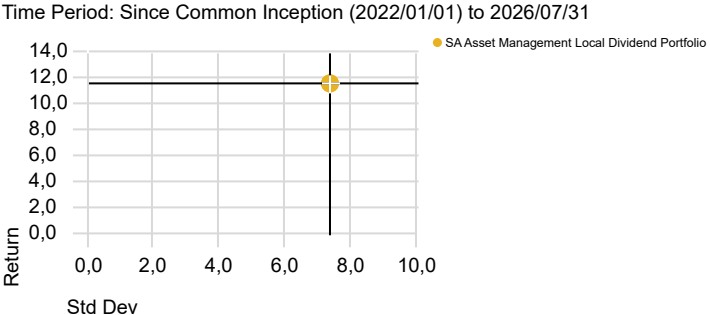

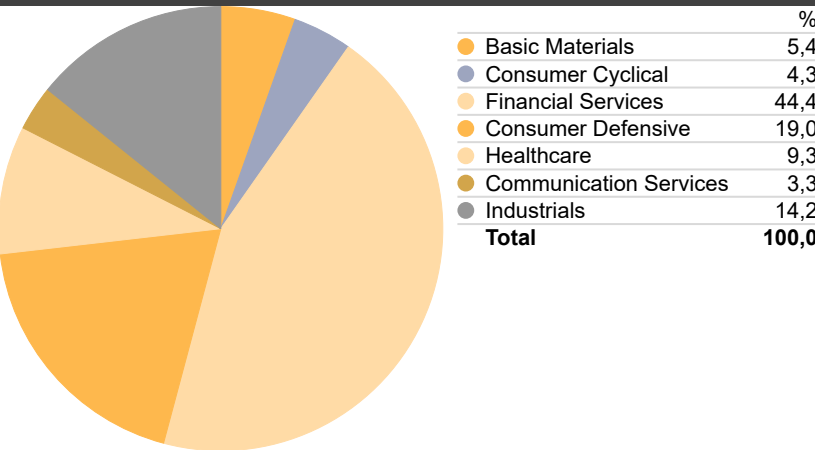

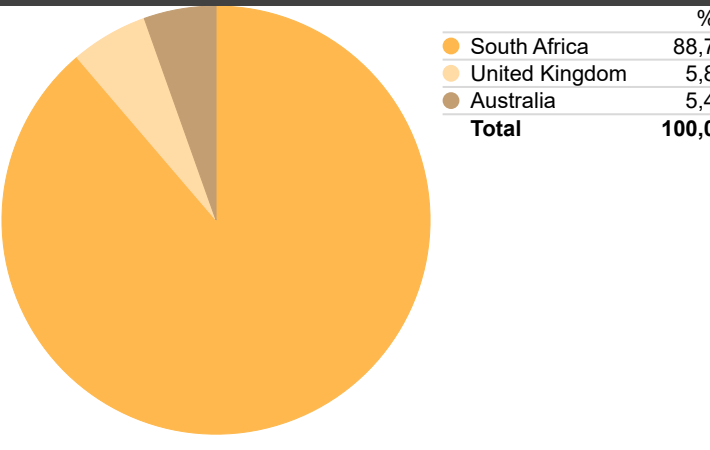
